Hill Creek School's original facilities were built in 1973; ongoing maintenance and campus improvements ensure facilities remain up-to-date and provide adequate space for students and staff. District maintenance and site custodial staff ensure that the repairs necessary to keep the school in good condition are completed in a timely manner. A work order process is used by school and district staff to communicate non-routine maintenance requests. Emergency repairs are given the highest priority. During Summer 2010, installation of solar panels was completed. Campus modernization was completed Summer, 2011.

Professional Development

All training and curriculum development opportunities at Hill Creek support the implementation of quality instructional practices in order to access the curricular content with an emphasis on the California Standards in English Language Arts, Mathematics, and Science (Next Generation Science Standards) as guided by curricular frameworks. At Hill Creek, certificated staff have 27 hours of professional learning time scheduled on site. These are considered partial days. Staff and administration define the use of these hours which are utilized for team meetings, whole staff professional learning, and interest-group meetings. Classified staff are also offered a variety of professional learning opportunities throughout the year involving their specializations from department supervisors and district representatives both on site and at the district.

Beyond the on site professional learning, certificated staff members participate in centralized training at the district level. They attend professional trainings focused on increasing learning loss. Staff members participate in a professional book study for the year. They also have access to a group of teachers on special assignment that work as Curriculum Resources Teachers. Using these resources, certificated staff can tailor professional learning to their immediate needs and receive small group and even one-on-one support. Certificated staff may complete a personalized learning plan each year and receive compensation for professional learning outside contracted hours. Decisions concerning staff development activities are performed by staff representatives, site administration, district administrators, using tools such as teacher input, district benchmark results, data analysis, and focus groups to determine the areas of need in which teacher training will enhance classroom instruction and

increase student achievement levels. Hill Creek offers support to new and veteran teachers through coaching and mentoring. Teachers are supported during the implementation of professional learning by checking in individually, with the grade level, faculty meetings and district wide review. All staff are encouraged to attend professional workshops and conferences including NGSS, GLAD, CGI, Restorative Practices, Open Sci-Ed, and CPM. Approximately 90% of our Staff Development is done on a partial day and approximately 10% is a full day of Staff Development. Classified support staff receive job related training from department supervisors and district representatives. All staff are encouraged to continue to grow as life long learners.
